INCLEMENT WEATHER:

In the event of inclement weather please contact the studio to see if there have been any cancellations or delays in the schedule. **We do not always follow the Harford County Schools decision on this issue.** Therefore, if there is any question regarding weather call the studio prior to leaving for class. A detailed message on the studio voicemail system will always be available when weather is a concern.

MAKE UP POLICY:

Sessions will not be extended and refunds will not be given **under any circumstances**-including weather, for missed classes. It is up to the individual to make up missed classes. Should a dancer miss his/her regular class he/she may make up the missed class by attending any other class at or below his/her level. You need not call to make arrangements for make up classes. When attending for a make up class, please let the instructor know at the beginning of class that you are there to "make up a missed class."

REGISTRATION AND PAYMENT:
